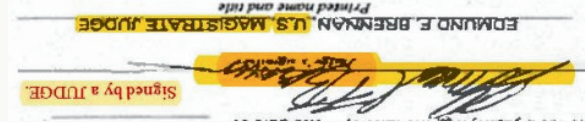


DO NOT OPEN THE DOOR

1 IF YOU CHOOSE TO SPEAK, ASK ICE TO SLIDE A WARRANT UNDER THE DOOR

The warrant must be signed by a judge and must also have your name and address.

WITHOUT THIS WARRANT, YOU HAVE THE RIGHT TO NOT OPEN THE DOOR TO YOUR HOME OR BUSINESS.



2 ASK FOR A LAWYER, THEN

REMAIN SILENT

DO NOT answer any questions, or sign any documents, without speaking to a lawyer.

3 DOCUMENT

You have the right to record ICE. Especially if you are a US citizen, document bravely. Take down badge numbers and names, and video.

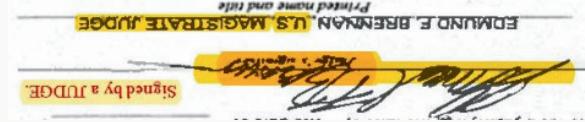


DO NOT OPEN THE DOOR

1 IF YOU CHOOSE TO SPEAK, ASK ICE TO SLIDE A WARRANT UNDER THE DOOR

The warrant must be signed by a judge and must also have your name and address.

2 ASK FOR A LAWYER, THEN

REMAIN SILENT

DO NOT answer any questions, or sign any documents, without speaking to a lawyer.

3 DOCUMENT

You have the right to record ICE. Especially if you are a US citizen, document bravely. Take down badge numbers and names, and video.

IN THE NEIGHBORHOOD

ASK: AM I FREE TO GO?

It is unconstitutional for ICE to detain you without a reasonable suspicion or a warrant signed by a judge. ICE says you are free to leave. LEAVE. You are not required to show your ID. If you are a citizen you can stand in solidarity by refusing to show ID and keeping the focus on yourself.

DO NOT CARRY OR PROVIDE FAKE ID. Do not carry ID from your country of birth; carry local ID and proof you've been here as long as possible (like a lease or electric bill) If ICE says you are not free to leave, and detains you, remain calm and do not resist.

4 DOCUMENT

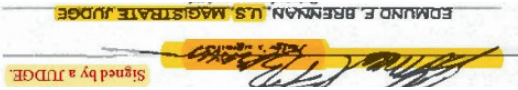

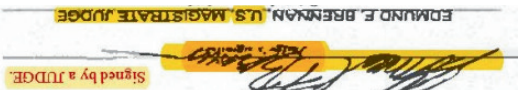
